GENERAL MEETING

Meeting held to update membership

Last Friday's general meeting was a lot shorter than the usual daylong meetings the membership is used to.

According to Southern Ute Tribal Chairman, Clement J. Frost the meeting was held so he and his appointed officials could update the tribal membership on their three-months in office.

Chairman Frost gave his update to the membership, focusing on the budget process and his concerns with the 10 percent workforce reduction taking place within in the tribe.

"[I have] a lot of questions on how that will effect the tribal membership and the services that are given to [the] tribal membership," Frost said. "We really need to address how to deal with the reduction and how that is going to effect the employment of the tribal members."

Vice Chairman, Melvin

Baker mentioned about 70 percent of the Permanent Fund's budget goes to paying employee salaries.

"We're trying to make it so we don't spend so much money," Baker said. "We are responsible for the Tribe's money, and we are looking for duplication of services. Are two departments doing the same job? And are we paying for that?"

Executive officer, Michelle Taylor Cruz, also gave a brief update on what she has been working on the last three months.

Since in office, she has been focused on tribal member concerns, as the current administration felt that was the first thing that needed to be addressed, Taylor Cruz said.

Taylor Cruz, also used her time to introduce the new Southern Ute Tribal Health Director, Lola Osawe.

OTHER UPDATES

Frost mentioned that the Tribe is looking for a new BIA superintendent.

There is currently an acting BIA superintendent until Tribal Council can find a qualified candidate, he said.


According to Frost, The general manager position at the casino still needs to be filled.

An individual was offered the general manager position of the casino, prior to Frost coming into office. Council is still awaiting the decision of the individual's gaming license, he said.

Members of the Southern Ute Growth Fund were also present to give a brief update on fiscal year 2014.

Like the Permanent Fund, the Growth Fund will also have a more detailed presentation later this month, when a Regular General Meeting takes place.

TRIBAL HEALTH

Lola Osawe becomes health department director

Every day, people become inspired by goals in their daily lives. Inspiration has been a driving force in achieving these goals as motivation brings it all together. For Lola Osawe, director of the Southern Ute Health Department, motivation has brought her to the Southern Ute Indian Tribe where confidence has allowed her to bring her medical experience to the fold.

Originally from California, Osawe had large dreams of going into space. But due to some unfortunate losses caused by health issues, it was evident her next goal was to pursue a career in health services. However, her pursuit in medical practice still allowed this astronaut to shoot for the stars.

Osawe's medical career began in 1998 while serving in the military as an Air Force active duty officer in management engineering and medical services. She is an executive as part of the American College of Medical Practice Executives with a Master's degree in Health Administration and a Bachelor's degree in Pre-med/Biological Sciences. She describes how her military background allows her to bring the right attitude to the table when aiding the Southern Ute Indian Tribe.

"I go by the core values: honesty, transparency, and teamwork," she said. "I truly believe teamwork is key and fundamental to our success. My style is collaborative leadership. That is how it has been since I arrived and how I plan to continue."

Prior to coming to the Southern Ute Indian Tribe, Osawe served with The Camden Group, a national healthcare consulting firm located in Southern California. She worked as a manager in the Physician Services division that specializes in physician organizations, including large medical groups and IPAs. Additionally, she

served as the ambulatory surgery center administrator for Huntington Memorial Hospital in Pasadena, CA. She supported 200 plus multi-specialty surgeons providing same day surgeries while managing six operating rooms. Patient care has always been her number one concern, and teamwork is what makes it happen.

"I want diversity in thought, unity, and purpose. The patients will see the results when we're all on the same page," she said.

As Osawe looks toward the future, she anticipates the up and coming changes of the Southern Ute Health Center as it continues to grow. With the addition of newer services, the health department is able to focus on the reconstructor of patient access, workflow, and the topic of behavioral health.

"We're hoping to engage in community health, improve patient access, and update

the policy and procedures," she said. "There is a vision of collaborating with behavioral health and supporting the citizens of the reservation. We have a great team to work with, and we have to address these issues because society is changing fast with so many pressures people deal with. If we address it now, it will help impact the youth."

With fourteen years of experience in healthcare operations under her belt, Lola Osawe hopes to continue to develop the Southern Ute Health Department towards a bright future. She is currently working toward her Doctorate of Health Administration. With the resources and knowledge at full swing, she made it clear that patient care is the main goal.

"Taking care of your people is truly more than a cliché. You need to take care of one another. That is what healthcare is truly about."

Rally continues to grow

The Four Corners Motorcycle Rally's gate attendance is up and it's an overall bigger event, according to Fairgrounds Coordinator and member of the Ignacio Chamber Events LLC, Mel Silva.

Bikers and spectators from all over the country flooded the town of Ignacio to take part in the annual Four Corners Motorcycle Rally Aug. 29-31.

"From last year to this year the attendance really showed," Silva said. "Last year, we didn't have enough people for more than one [event] going on, and this year we did ... it just felt like a bigger event."

Silva attributes the increase in attendance to a new approach in advertis-

ing, and the closing of a competitors rally.

"We did a lot more online advertising with Google and Facebook, where last year we hardly did any," he said. "Instead of full page ads in publications; we did smaller ads."

Online advertising allowed the target demo-

graphic to be reached more accurately, Silva said. Ads in publications were still important, but were scaled back to allow money to be spent on more precise advertising.

Another big factor in attendance can be attributed to

## IT'S YOUR VOTE • IT'S YOUR TRIBAL COMMUNITY

The Election Board has determined these are the dates for the upcoming 2014 General Election, according to the Constitution and the Election Code.

**SOUTHERN UTE GENERAL ELECTION: Friday, November 7, 2014**

### GENERAL ELECTION RESIDENCY DEADLINE: Friday, August 8, 2014

**Constitution; Article IV, Section 5:** A candidate shall physically reside within the present exterior boundaries of the Southern Ute Reservation for at least ninety-days (90) preceding the election.

### STATEMENT OF INTENTION DEADLINE: Monday, September 8, 2014 by 5 p.m.

**Election Code 11-3-101 (3):** A Statement of Intention shall be filed with the Election Board not less than sixty-days (60) preceding the date of the General Election.

### ELECTION BOARD DECISION REGARDING ELIGIBILITY DEADLINE: Tuesday, September 23, 2014

**Election Code 11-3-102 (2):** Any decision of the Election Board regarding eligibility shall be made at least forty-five (45) days before the election

### NOTICE OF ELECTION: Wednesday, October 8, 2014

**Election Code 11-4-102 (1):** Election Board shall post notices of the election within the Southern Ute Reservation at least thirty-days (30) before each election.

### VOTER REGISTRATION DEADLINE: Wednesday, October 29, 2014 by 5 p.m.

**Election Code 11-1-104 (1):** Any enrolled Southern Ute Tribal member, 18 years or over, shall register themselves to vote by this date and time to be qualified to vote at the upcoming election. The deadline to do so is seven (7) business days before the election.

### ABSENTEE BALLOT REQUEST DEADLINE: Wednesday, October 29, 2014 by 5 p.m.

**Election Code 11-5-102 (2):** The application, letter, or telephone call requesting an absentee ballot must be received by the Election Board no later than the close of business at least seven (7) business days before the election

### EMERGENCY BALLOT REQUEST DEADLINE: Thursday, November 6, 2014 by 5 p.m.

**Election Code 11-5-107 (1) (2) (3):** A voter may make a written request that the Election Board provide him an emergency absentee ballot if: (a) He will be confined in a hospital or at his place of residence on election day because of events arising after the deadline for absentee ballot requests; or (b) He must be absent from the reservation on election day and the reason for such absence arose after the deadline for absentee ballot requests. The written request shall contain the following: (a) the voter's name and address; (b) The nature of the emergency causing confinement or absence from the reservation; and (c) The voter's signature.

The emergency ballot request must be made before the day of the election. The Election Board shall review emergency requests on a case-by-case basis. If the Election Board determines not to grant the request, the voter shall be promptly notified of the denial and the reason. If the Election Board determines that the request should be granted, the Election Board shall deliver the emergency absentee ballot at its office during regular business hours or, in the case of a medical emergency, at the place where the voter is confined.

### GENERAL ELECTION: Friday, November 7, 2014 – 7 a.m. to 7 p.m.

**Constitution; Article IV, Section 1:** There shall be annual elections on the first Friday in November.



The Sugar Pine Motorcycle Rally in Mancos going out of business; Silva believes a lot of their bikers came to Four Corners instead.

Locally, the rally was advertised as an event for everyone, not just those with motorcycles; playing up the

"It's just a bigger event, and whenever it's a bigger event people are more interested," he said.

No official numbers are in yet, but Silva believes the

# KC denies Volleycats in opener

If Nadia Watson was looking to “thank” her alma mater, consider it done.

“I really think of it [as] ‘paying it forward,’” she said. After winning her varsity head-coaching debut Thursday, Aug. 28, in the building where the former basketball standout once starred.

“I mean, Kirtland Central gave me such a great opportunity to play at another level, and for schooling ... and has really prepared me for the next level. And if I can do half of what Kirtland Central’s done for me as a student-athlete for these girls, I think I’ve accomplished my mission.”

Victimized in the Lady Broncos’ 25-18, 25-18, 25-15 victory, however, Ignacio left Bronco Arena knowing they had stayed closer – other than in Game 3 – to the New Mexico squad than the scores showed.

“Being a young team, they’re just getting through the mental stability. They’ve all bought into our fast offense we’re running, and the tough serving,” veteran boss Thad Cano stated. “The tough serving wasn’t there tonight; it kind of came, went, sparked once in a while. We’ve just got to be consistent ... and the passing, serving, everything else will come together.”

“They’re looking forward to next year, them coming up to us!” he added, of the growing KCHS-IHS, 4A-versus-2A rivalry that had seen its previous two editions each go five games. “They’re loving it!”

Game 1 was about as mutually shaky as could be expected; of the 43 combined points, 30 – including the very first ten, resulting in a 6-4 Kirtland lead, and the very last – were won or lost via errors.

“Our serving and our passing really got to us,” said senior Amya Bison, who served wide on game point not long after consecutive tide-turning aces by KC’s Alex Cambridge. “I think if we would have had our serves, I think we would have done good as far as not letting it get to us mentally.”

Thompson’s first prep-level ace, pulling the Cats back to 19-16, had been the team’s brightest highlight, and after sending her next one long, she buried her next try perfectly into the deep corner for a 3-0 lead early in Game 2, after Cambridge opened with a misfire from the line.

Central recovered to tie at 4-4, but Bison then crushed a Thompson quick set to again put the Lady Broncos in chase mode as Ignacio (0-1, 0-0 San Juan Basin League) matched their maximum margin at 9-6 before KC re-tied at 9-all and subsequently built themselves a three-point pad at 13-10.

But starting with junior Ellie Seibel’s tip tight to the net and a Cambridge hitting error, IHS clawed back to take a 15-14 lead on a Bison block before Kirtland regained the advantage for good at 19-17 after two Krystal Sheka serves proved too tough to handle.

The Lady Broncos (1-0, 0-0 Dist. 1-4A) then went up two games to zero in the match when senior Kaleigh Case cracked an ace off Volleycat freshman Avionne Gomez.

“We’re a little rocky,” said Bison. “Kind of just

broke down after that.”

Opening Game 3, Thompson atoned for a service error with a clever set-dump, but KC then went up 2-1, then got a Morgan Farley ace and were off and running, never to be caught as their lead eventually grew to 18-8, 19-9 and 20-10. A kill by junior Deiondra Smith and a tip by senior middle Koelle Bradley officially sealed the deal.

“These girls have really come into themselves,” said Watson. “Really stepped up to the plate – which was nice to see because I was a little worried, honestly!”

“I told ‘em that we’re going to go through these growing pains,” Cano said, of his side. “They kept attempting and that’s what I like – they never quit trying to run quicks we’ve been practicing...if we don’t run ‘em we’re not going to learn, not going to get better. They’re going to pay off in the long run!”

# Bulldogs wear down Bobcats

Passing attack stays potent in loss

One slogan spotted stated ‘Friendliest Town Around.’

Another advertised ‘Neighbors Helping Neighbors.’

Both certainly seem inviting enough to any visitor, and Nick Herrera, like many Bobcats aboard the bus, probably saw the former on a sign as State Highway 92 descended into the destination.

He was likely one of only a few who didn’t see the latter.

Nobody, especially head coach Lupe Huerta, wanted to see that; it adorned each side of the North Fork Ambulance into which his junior tight end/defensive end was unfortunately inserted with 5:19 left in the third quarter – and Ignacio behind by just ten – of what ended up a 32-14 loss, Friday, Aug. 22 in Hotchkiss.

Also downed after a Bulldog’s foot compressed his neck during the same play’s pileup, but able to eventually walk off, sophomore d-liner Michael Cruz first saw his teammate into the rescue ride, then returned to an re-inspired huddle of hungry Bobcats – ready to finish ‘Zero Week’ with authority.

And HHS boss Mike Sirko, who’d started each of the last two seasons at 2A Aspen against IHS, knew how important it was for his own side to not only finish likewise the contest, but that very drive.

“Their kids ... they’re playing tougher. Last year I felt they were a much-improved team, and I think they’re improved this year!” he said. “I mean, we struggled and they did some good things – they had some injuries, and that takes the wind out of your sails, but I will tell you ... they’re on the right track.”

“We did some good things and we did some bad things,” admitted IHS senior quarterback Adison Jones. “But we moved the ball good against a playoff team; we were in there with them. It just felt good.”

Led by the three-pronged ground attack of QB Devan Rupe and running backs Wade Katzdorn and Duncan Turnbull, the Dogs chewed up nearly 300 clock-killing yards’ worth of their already chewed-up field, and capped the crucial 9-play, 45-yard march with a four-yard Turnbull touchdown (his third of the night) and two-point Katzdorn conversion for a 26-8 advantage with

3:28 left in the third.

That push set up by junior Cole Carvill’s interception of Jones, on the third play after Hotchkiss (1-0, 0-0 Western Slope) completed an 8-play, 69-yard surge beginning the second half with a 13-yard Turnbull run – Herrera deflected Rupe’s two-point pass attempt – for the referenced 18-8 lead, the Cats had seen enough to know they’d seen too much.

To that extent, most vocal during the aforementioned team gathering was Miguel ‘Mike’ Perez, and the senior RB responded by turning a short Jones toss into a 17-yard score with 11:46 left in the game, finishing a 9-play, 71-yard assault – in which IHS (0-1, 0-0 Southern Peaks) ran the ball just once.

“Oh it felt great! Just to be able to lead the guys over for one more touchdown,” said Perez. “To get that fire started – we’re a team, we’ve got to play as a team. It’s not just one person that sets it off.”

But after Rupe disrupted Jones’ two-point try, leaving the score 26-14, one person off – as in junior defensive back Chase Sanchez, drawn offside by Rupe’s cadence under center – on a Bulldog 4th-and-1 at the Ignacio 22 allowed HHS to prolong, and complete an 11-play [all runs], 72-yard response with a two-yard Katzdorn dive [Jones blocked senior Michael Nault’s point-after kick] and only 7:10 remaining.

“In the second half I felt we kind of got it together a little more,” Sirko said. “The one thing that I was concerned about a little in the first half was that we went out there and then we kind of lost our momentum all of a sudden.”

And just as Jones’ arm had found Hayes earlier to get the Cats on the scoreboard, cutting

Hotchkiss’ lead to 12-8 [Jones hit Herrera for the two-pointer] with 2:56 left in the second, air raids – Jones was unofficially 21-of-43 for 228 yards – allowed Ignacio two late, desperate series in the fourth.

Receivers found plenty of open space – Hayes caught 12 balls for 111 yards unofficially – as well, but first-game drops and timing issues prevented IHS from posting any more points, led to two (of four) turnovers-on-downs, and Rupe then knelt twice from the Bobcat 21 to consume the final 43.8 seconds.

“Overall I’m proud of them,” said Huerta. “Just have a lot of work to do. We had some opportunities and just didn’t take advantage.”

“The passing game, like last year...we can pass left and right – never had an issue,” he continued. “Pass protection? The line did fantastic; I don’t think Adison got touched [other than] a couple times!”

The Cats pass game is flowing, and the run offense will come along as the linemen improve, Perez said.

“All the kids know...Zero Week? You’re not in the best condition in the world and everything else,” said Sirko in practical agreement, “but that’s something we’ve got to deal with and get better with.”

Ignacio’s home opener, and official unveiling to the public of IHS Field’s new surface, awaits them next – as will visiting Paonia – in 2014’s Week 2 on Friday, Sept. 5 with kickoff at 7 p.m.

“It’ll be good,” said Hayes of facing the reigning Class 1A State Champions. “To be the best you’ve got to take out the best, so that’s what we’re going to try to do!”

PHS (0-0, 0-0 WSC) began its title defense Aug. 29th at home against Monte Vista (0-0, 0-0 SPC).



### THINK BISON!

Hello Tribal membership, greetings to all.

I am happy to announce that I am the new Inter-Tribal Buffalo Council Bison Instructor. In short, the Bison Instructor housed at the Southern Ute Cultural Center. I would like to acknowledge Samantha Greany for starting the first phase of developing a Bison Cookbook. The cookbook is one of the projects to undertake from a grant made possible from the Inter Tribal Buffalo Council of Rapid City, South Dakota. (ITBC).

Maintaining a healthy herd is crucial and is dutifully managed by the Bison Herd Program Manager, Chris Olguin of the Southern Ute Tribal Wildlife Division. Olguin manages approximately 30 head within a 350 acre fenced pasture.

To continue the sustainability of the herd and to incorporate dietary wellness uses, the Wildlife Department focused on a new vision for surplus animals – to start dispensing bison meat to benefit the membership. According to Lovvis Downs Glass of Tribal Wildlife Division the interest was low. By word of mouth and numerous taste test demonstrations it has grown from 20 people to 338 requesting bison meat and the popularity is growing. Therefore there is a need for a cookbook based on recipes from Southern Ute Tribal members and others of the community who cook with Bison.

If you cook with Bison and would like to share your recipe, it will be featured in the cookbook. Look for "tastes test" in the future as well as educational material; i.e. nutritional value of Bison, cooking tips, and the many uses of Bison.

Think beef ... think BISON!

The Bison Program Taste Test held on Wednesday, Aug. 27 at the Cultural Kitchen in Ignacio, Colorado was a successful turnout. Many thanks to those who attended, not one morsel was left! ### DEAR FELLOW TRIBAL MEMBERS

I am writing to give you information so you will be aware of what state our Tribe is in when it comes time to vote. Actions are being taken that are not in the best interest of us Tribal Members but the Council says it is. I want you all to make the decision on whether the Council's actions are for you, the ones who voted them in.

The Council lied to us when they sent a letter saying we were getting medical insurance. This is NOT medical insurance BUT it is third party billing company who is supposed to get our medical bills lowered. We were told nothing was to change in our previous coverage when this so called insurance was to kick in. This is also a lie, because now, Tribal Members are being denied service by the THIRD PARTY COMPANY because they don't feel Tribal Members need the medical care they are seeking. The Tribe still pays these bills, which is different than insurance because if it was insurance like they sold it to the Membership, they Tribe would not be paying for the medical bills.

The current Council is showing a lack of respect for each other as a Council and that just trickles down to the Membership. Although they may not personally like who is on the Council, they need to be adult enough and respect the Membership's decision on who was elected by the People of the Southern Ute Indian Tribe. When they treat each other with disrespect they are disrespecting OUR decision to put who we elected to fill those positions. This also shows the lack of understanding of traditional values of respecting Elders and elected officials, as we are taught. Therefore, the Council is acting like they are above the Membership. When this happens, Tribal Members no longer become the focal point so the decisions made are not in the best interest of the Tribe.

Tribal Member employees who are not liked by the Council have a hard time succeeding and moving up the ladder of the Tribe. This PERSONAL mindset of Tribal Council is not for the benefit of the Membership and is another stance against the Membership. Council Members do not know who votes for them and may have received a vote from the Tribal Member the Council Members consider not being

worthy of encouragement from the Tribal Council. This attitude takes away from the community approach that Utes have lived by, which diminishes the cultural aspect of the Tribal Council.

Services are being taken away from the Membership, especially the children, through the budget process so it does not have to go before Council for a vote. Questions that arise from this practice are: 1) What is the reason Council feels they need to take away services that have been received by the Membership for years; 2) Why do a few Council Members feel they can make decisions for the Tribe as a whole and not include all the elected officials; and 3) most Council Members do not have any minor children, so how do they know what our children need? These are the questions you need to keep in mind when you vote in ALL elections.

The Council indicates this is a way to save the Tribe money, but a better way to achieve this would be to streamline the Tribal Organization and eliminate staff that is not necessary. We, the Tribe, are wasting money by continuing to fund positions, programs, and departments that have completed their usefulness or no longer providing a viable service to the Tribe and its members. Evaluating the Tribal Organization instead of the services offered by the Tribe to its members is a much better Tribal Member friendly solution.

Transparency is always being talked about by the Council, but did you know they have discussions regarding Council agenda items while off the record then only go on record to say whether it is approved or not. This keeps the Tribal Membership in the dark as to what is being discussed and how and why a decision is made. This practice does not hold the Tribal Council accountable when a decision is made that the Membership does not feel it is in the best interest of the Tribe. How is discussing information "behind closed doors" being transparent and being open with information to the Membership? This is a practice that has occurred over more than a year that I am aware of.

The Membership is loyalty to those who are not loyal to them. It is time to be loyal to you, the Membership and take a good look at who is really watching for the best interest of the Southern Ute Indian Tribe.

Please be an informed voter!

This permit action will apply to an existing facility operating on the Southern Ute Indian Reservation in Colorado.

This facility is an existing coal-bed methane gas compression facility. The facility currently holds a Federal operating permit issued by the U.S. EPA Region 8 Air Program pursuant to the Title V Operating Permit Program at 40 CFR Part 71 (Part 71). The permit contains emission limits created by the EPA. The creation of the emission limits in the Part 71 permit was a temporary, gap-filling measure for those sources operating in Indian country that did not have the ability to obtain these limits through pre-construction permitting programs, such as exists in state jurisdictions.

Upon promulgation of the Tribal Minor New Source Review Program at 40 CFR Part 49 (MNSR), implemented by the Federal government, and the approval of the Southern Ute Indian Tribe's Title V Permit to Operate Program (Part 70) implemented by the Southern Ute Indian Tribe, it is now necessary to transfer these limits to the appropriate MNSR permits before the Southern Ute Indian Tribe issues new Part 70 permits.

**Proposed Permit Requirements:**  
The Jaques Compressor Station permit proposes requirements to use air pollution controls and limit the emissions of hazardous air pollutants from dehydration systems and engines operating at the facility. The Jaques Compressor Station permit proposes requirements to use air pollution controls to limit the emissions of total hazardous air pollutants, as well as formaldehyde and benzene.

**What are the effects on air quality?**

This action will have no adverse air quality impacts. The emissions at this existing facility will not be increasing due to this permit action. In addition, this action does not authorize the construction of any new emission sources, or emission increases from existing sources, nor does it otherwise authorize any other physical modifications to the facility or its operations.

## FLY-FISHING

# River of Lost Souls: North of Durango

The River of Lost Souls, also known as the Animas River, downstream from Durango has always been a fun and challenging fishery. From the 32nd Street Bridge south to Bondad, the Animas is known for big browns and rainbows. It is also known for fish that have very discriminating appetites similar to a two-year-old child. In addition, you are fishing amongst the rubber hatch, rafters, and lots of other people. Flyfishing in this area can be very frustrating.

To avoid the crowds and frustration I suggest you go north and fly-fish the Animas around Silverton and Howardsville. This area is better known for mining, and what the mines put into the water. Despite the damage to the river from the mines, the fly-fishing is very good. I have heard rumors of trout with two heads and brains as the result of the chemicals from the mines. I have to say those are false stories. I have caught trout in this area, and a trout with one brain the size of a pinhead is always challenging for me. If the trout had two heads and brains I would never catch a fish. Therefore, my scientific study proves the trout in the Silverton and Howardsville area have only one brain.

The river between Sil-



verton and Howardsville is somewhat similar to the Animas around Durango. The river can be wide, deep, and fast during spring runoff. Once the runoff subsides fishing gets good. The river is wide enough to make an easy back cast, and shallow enough to warm up quickly. The wading, while now inviting, can be extremely difficult. The same person that polishes the river rocks in the Animas around Durango is also employed between Silverton and Howardsville. Be sure and use a wading staff.

In this area you can expect to catch brook and rainbow trout. I have caught some good-sized fish in this area, however they are not as big as those caught around Durango. For me, what makes this really a fun day is the total absence of other fishermen. I fished it a couple of weeks and was all alone. It was great.

North of Howardsville, the

Animas takes on a completely different characteristic. The river becomes shallower, and is much easier to wade. Even though the streambed is small gravel instead of big polished rocks, I still recommend a wading staff. This part of the Animas is strictly brook trout. I have no scientific evidence for this, just my experience. There are a large number of deep pools with a gentle flow, making this a good place to learn how to fly-fish with nymphs. If you're not into nymphing, welcome to a world of very aggressive trout just looking for dry flies. The shallow water having lots of riffles is the perfect place to fly-fish with a two-or three-weight rod.

While on this part of the river, don't overlook the beaver ponds. I love to fish these ponds when the spring runoff makes everything else un-fishable, and the ponds are overflowing with very, hungry, and smallish trout. This is also a great place to take someone who is just learning to fly-fish. It is the perfect spot to build confidence. It's where "Grumps" plans to watch the world's cutest and smartest grandchildren laugh and have fun when they get big enough.

So, if the Animas around Durango gets too frustrating or overcrowded for you, don't give up. I suggest you head north. It is worth an hours drive.
