Leonard C. Burch Remembered As Inspired Leader

As the time comes once again to honor Leonard C. Burch, longtime leader of the Southern Ute Indian Tribe, his legacy continues to thrive in southwestern Colorado and abroad.

Burch was born in 1933 and died at Mercy Medical Center shortly after sunrise on Aug. 1, 2003, following a cardiac arrest suffered the previous day. He was 69.

Burch's retirement in December 2002 brought to a close a brilliant political career. He served as chairman of the Southern Ute Indian Tribal Council for more than 32 years, commencing with his first election as chairman in 1966.

Under his leadership, the Southern Ute Tribe emerged from relative poverty to become a major economic force in the Four Corners region and the largest employer in La Plata County. Fueled principally by successful development of the Tribe's natural gas resources, the Burch era saw countless examples of community development and improvements in education, health and social programs available to tribal members.

Upon graduating from Ute Vocational High School in 1954, Burch enlisted in the U.S. Air Force. His four years of military service included a tour of duty in Turkey. Upon his return to the Southern Ute Indian Reservation, he spent five years working in the Realty Office of the Bureau of Indian Affairs where he became familiar with oil and gas leasing and land title matters.

During this same period, he married Irene Coolidge, a Navajo tribal member who had also attended Ute Vocational School in Ignacio. As soon as he became eligible under the Tribe's Constitution he ran successfully for a position on the Tribal Council and, at the age of 32, was selected by his fellow Council members as chairman. For more

than three decades he was re-elected as chairman of the Tribe with the exception of intermittent breaks mandated by term limitations set forth in the Constitution.

While a strong voice for tribal self-determination, he was also committed to maintaining cooperative relationships with the United States government, the state of Colorado and neighboring governments. He was invited by five separate U.S. presidents to attend conferences on Indian policy at the White House. During his tenure he appeared innumerable times before committees of Congress on matters affecting the Tribe and southwestern Colorado.

He successfully obtained passage of federal laws permitting the Tribe to consolidate land holdings within the reservation and addressing complex jurisdictional issues. The gaming compact between the state of Colorado and the Tribe and a taxation compact among the state of Colorado, the county of La Plata and the Tribe were each negotiated during his tenure in office.

Burch was also noted for his commitment to regional water resource development. He helped forge a coalition of Indian and non-Indian water users in southwestern Colorado to advocate for construction of the Animas-La Plata Project, a water storage facility built by the U.S. Bureau of Reclamation as part of a settlement of the Tribe's water rights claims. In recognition of his role in this regard, he received the Citizen Award from the Bureau of Reclamation.

Burch's cooperative practices were also reflected in other matters.



For example, the Tribe's water and wastewater treatment facilities constructed during his tenure continue to provide services to both Indian and non-Indian communities within the Reservation. He received numerous awards in recognition of his lifetime achievements and contributions, including the Durango Area Citizen of the Year Award (1997), the 15th annual Martin Luther King Humanitarian Award (2000) and the Council of Energy Resource Tribes' Achievement Award (2003).

In the later years of his career, he worked closely with other members of the Tribal Council to establish and implement successful financial investments both on and off the Reservation. The financial progress of the Tribe has been widely touted as a model for Indian tribes across the country.

Throughout his life, Burch remained respectful of the culture and traditional ways of the Ute people. He participated continuously in the Southern Ute Indian Tribe's Sundance as both a dancer and Sundance chief, and he supported programs to preserve the Ute language and the Tribe's museum.

His life was one of dedication and service to his family, the Southern Ute Indian Tribe, and the Four Corners Region.

The U.S. Housing and Urban Development's Colorado office sponsored an event Nov. 18 to honor the Ute tribes of Colorado in conjunction with Native American Month.

Colorado's American Indian Special Emphasis Committee hosted the event and provided an Indian taco luncheon at the UMB Bank building in downtown Denver. Randy Akers, administrator of HUD's Northern Plains Office of Native American Programs, welcomed attendees and Ellen Dole, acting director for Region VIII of HUD's Office of General Counsel, read a proclamation from President Obama. Deidre Blood, chair of the committee, acknowledged the Ute

Indian tribes and then introduced Chairman Ernest House Sr. of the Ute Mountain Ute Tribe and Vice-chairman Jim Newton Jr. of the Southern Ute Tribe.

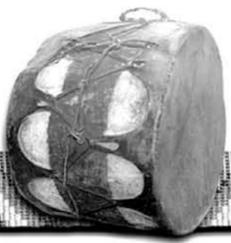
House spoke first on behalf of the his tribe and shared his political and personal background, which has encompassed 24 years on the Ute Mountain Ute Tribal Council and experience as an active Sundancer, a father of three, and one of 2,085 members of the Ute Mountain Ute Tribe. He said he has served four terms as chairman of the Ute Mountain Ute Tribe and this will be his last. House spoke about growing up on the reservation and attending boarding school.

"I learned to take care of myself when I was in public school in Cortez, Colorado, and took advantage of the relocation program and moved to San

Francisco, California," he said. "It was tough."

After finishing school in California, House joined the military during the Vietnam era. He spoke briefly about his experience. He then talked about the Ute Mountain Ute Tribe's many accomplishments related to gaming, farming, and their recent hydro-planting venture. The tribe strives to continue successful business through generations by making the pathways for the future, he said.

House also talked about the importance of health and the loss of many tribal members to diabetes. He acknowledged that he himself lives in a HUD home and said he was grateful when he received that home. House closed with a nod to the past.



Tribe Welcomes Canadian Visitors

Representatives of the Siksika people of Alberta, Canada, visited the Southern Ute Indian Reservation Nov. 17-20 as part of a cross-country trip to learn from successful tribes about tribal government and cultivation of resources. The delegation met with tribal departments including the Executive Office, Permanent Fund and Sky Ute Casino Resort. The Siksika have hopes to become self-sufficient by investing in energy and casino resources. The visit also included discussions on intergovernmental relationships – those between the Southern Utes and the United States and between the Siksika and Canada. The Siksika delegation has also visited the Navajo, the Choctaw and the Creek during its tour. The word "Siksika" means "Blackfoot." They are part of the Blackfoot Confederation, which includes the Blackfeet of Montana..



Express Your Opinions

Considering The Run-Off Candidates

Four candidates will face off for two seats on the Southern Ute Tribal Council on December 18, 2009.

When I attended "Meet the Candidates" Night and listened to all of the candidates speak I was thinking that some of these people cannot control their own lives or the lives of their children, and some cannot hold a job because of their personal history.

In my own personal history, I was taught many things from Tribal Elders, from this Tribe and other tribes. I respect those people and those teachings. My family religion was in the Native American Church and I learned the cultural ways and the language of our Tibe from my family. I started Sundancing on Towaoc with Terry Knight, and here in Ignacio with Eddie Box, Sr. and Neil Cloud. In all of those teachings and all those ceremonies with all Elders, I was told to never lie to my people or anyone, to not steal from them, and

to never harm any fellow human being. These things were against the laws of the Creator. Even in the Catholic Church, where I was educated for three-and-a-half years, these things are taught.

Respect is earned...not given. Breaking the rules or changing policies for your own benefit, being mean to others, and then demanding respect is crazy. The way you treat others is how you are treated. You cannot go around and blame others for what you have done to yourself. You can't change documented history.

We have one candidate, Joycelyn Dutchie, who has stolen from the Tribe. She was charged in Federal Court, and pleaded guilty to the charge (Durango Herald, December 22, 2001 and January 16, 2002). Somehow, Mrs. Dutchie still made it onto Southern Ute Tribal Council. Did she learn from her mistake? Not really. She was accused of misusing the Tribal credit card (Durango Herald, May 14, 2003). The Tribal Ethics

Committee reviewed the charge, and determined that it was true. Even a review of that ruling upheld the decision. The Tribal Council members at that time did not dismiss her, failing the Oath of Office they had taken on behalf of all Tribal people. Some members of that same Council wanted to turn Southern Ute Veterans Memorial Park into a parking lot.

I am sure that many of our Tribal members who voted for Mrs. Dutchie are more educated than she is, and I am sure that about half of them hold jobs for which she could not qualify. Remember, if you vote for her you could possibly have a Council member who has a criminal record, very little education, and her continue dishonest to her own people

I have always asked, "Would your trust this person to represent you in a court of law if your life depended on it?" I would not.

December 18, 2009

The Election Board has determined these are the dates for the upcoming 2009 Run-Off Election, according to the Constitution and the Election Code.

- Run-Off Election - December 18, 2009
- Official Voter Registration Deadline - December 7, 2009 by 5:00 p.m.
- Absentee Ballot Request Deadline - December 7, 2009 by 5:00 p.m.

The application, letter, or telephone call requesting an absentee ballot must be received by the Election Board no later than the close of business at least seven (7) business days before the election.

- Emergency Ballot Request Deadline - December 17, 2009 by 5:00 p.m.

A voter may make a written request that the Election Board provide him an emergency absentee ballot if: (a) He will be confined in a hospital or at his place of residence on election day because of events arising after the deadline for absentee ballot requests, or (b) He must be absent from the reservation on election day and the reason for such absence arose after the deadline for absentee ballot requests.

The written request shall contain the following: (a) the voter's name and address, (b) The nature of the emergency causing confinement or absence from the reservation, and (c) The voter's signature.

The emergency ballot request must be made before the day of the election. The Election Board shall review emergency requests on a case-by-case basis. If the Election Board determines not to grant the request, the voter shall be promptly notified of the denial and the reason. If the Election Board determines that the request should be granted, the Election Board shall deliver the emergency absentee ballot at its office during regular business hours or, in the case of a medical emergency, at the place where the voter is confined.



"My Former Shadow" Health Challenge

The Health Disparities Grant of the Health Services Division announces a great new 3 month challenge for Native Americans of any tribe who are 20 years or older. (Non natives can participate as challenge buddy to a Native American.) We want to screen you for cholesterol and glucose and help you meet the goals that you set after an assessment of your strength, flexibility and cardiovascular system. The program will start Friday Dec. 4, 2009 AND we would like to screen you before then. Call Henry Sun Eagle at (970) 563-0154 Ext 2344 or Lynne Murison at (970) 563-0154 to schedule an appointment for screening and assessment. (Two times— one for blood screen, one for strength, flexibility and cardiovascular screening.) Plan to fast (nothing but water or black coffee only) for 8-12 hours before your glucose and cholesterol screening (which we will do in the Health Services Building). We're calling this phase of My Former Shadow: the Holiday Challenge, because you're brave enough to start with the holidays. "It is the winter season: a time for storytelling," he said. "It is an honor to be here in Denver, Colorado, because Denver is the crossroad for our Native American people throughout the United States. I would also like to thank our warriors for the sacrifices which has allowed us to be here today."

Blood then introduced Newton, who began by acknowledging the AISEC for having the two Ute tribes in Denver to celebrate Native American Month. Newton said the Ute tribes have seven bands, and that he comes from the Capote band. He also gave a glimpse of the Ute history, explaining that the Utes are the oldest residents of the state of Colorado and that they were one of the first tribes to embark on trading with the Spanish for horses.

Newton also spoke of the Meeker Massacre and the significance that it had on Colorado history.

"Meeker tried to force our Northern Utes to become farmers on land that was not farmable, which then led to the Meeker

Massacre," he said.

He also spoke of the Brunot Hunting Agreement and how the Colorado Ute tribes have begun to take advantage of the wildlife and hunting opportunities that are now available in designated areas throughout the State of Colorado.

Newton also addressed the Homestead and Allotment Act and how land was taken from the Utes and never returned, resulting in our current reservation — an area of 75-by-15 miles, a fraction of what was once Ute territory. He alluded to the Indian Reorganization Act of 1934, which allowed the tribe to develop a constitution and govern itself within the reservation.

Newton then touched briefly on the Southern Ute Indian Tribe's Financial Plan and the history that brought the Growth Fund to life in 1999. He talked about the Bureau of Indian Affairs' lack of trust responsibilities and how the Southern Ute Indian Tribe has taken over the health center.

"John Salazar has opened the door for Indian people in

Colorado, and we look forward to working with him in the future to secure business and living for our Southern Ute people," he said.

In closing, Newton touched lightly on the infamous quote "The Utes must go," voiced by Gov. Frederick Pitkin, who strived to force Ute hunters to become farmers during the Meeker Massacre.

"The State of Colorado has never offered an apology for that statement to this day," Newton said, "but we stand here today as strong Indian people who will continue to strive for the betterment of our people and our future generations."

He also invited those in attendance to the Southern Ute Reservation for the Spring celebration, the Bear Dance, and thanked those in attendance for their time.

In closing, Blood presented House and Newton with plaques for attending as guest speakers. Andy Cozad of the Kiowa Tribe closed the presentation with an Honor Song for those in attendance.

Tribe Speaks At DU Law

The Native American Law Student Association hosted a question-and-answer forum Nov. 19 during Native American Awareness Week at the University of Denver's Sturm College of Law. Barbara Scott-Rarick of the Southern Ute Tribal Council and Chairman Ernest House Sr. of the Ute Mountain Ute Tribal Council were on hand to talk about the importance of having tribal attorney representation. They also discussed the different areas of law that attorneys need to know to work for a Native American tribe.

The day before, NALSA sponsored Ute Mountain Ute Tribal Attorney Peter Ortego as he gave insight into what his responsibilities are as a tribal attorney and various laws he deals with as general counsel. The association also held a silent auction with various items like native jewelry, paintings and pottery. The week also included an Indian taco sale on Nov. 15 to raise money for the association.

The main areas of law that tribes deal with include employment, energy, criminal, tax and Indian law. Others, like jurisdiction, oil and gas, natural

resources, renewable energy and water, include smaller focuses. Tribal lawyers have to be aware of all areas and must be experts in all aspects of law. There are also lawyers who specialize in specific areas of law — for instance, tort lawyers, who work on personal injury cases, workman's compensation and similar issues.

Shelly Thompson, a Southern Ute tribal member and law student at DU, said she has learned

that regardless of how much people learn about Native Americans, Indian law is often pushed to the backburner and the rights Congress has given to tribes are revoked by the Supreme Court. It's imperative that Native American people learn about Indian law so they can make positive changes, she said. Thompson will be graduating on Dec. 15 with a juris doctor.

New Law Limits The Use Of Cell Phones While Driving

Prior to December 1st, all drivers were free to use cell phones, and to send texts, tweets, and whatever else cell phones may do, while they were driving 70 miles an hour down the roadway. While such actions may have been legal, they were not a good idea. Anything that diverts a driver's attention away from the roadway makes the driver more susceptible to causing and/or

being in an accident.

This all changed on December 1st. With the new law, no driver under the age of 18 can use a cell phone, for any reason, while driving. A driver under the age of 18 can't call someone while driving, can't talk on their cell phone while driving, and can't send/receive emails, send/receive text messages, and tweet. This prohibition applies to all cell phones, including hands free phones. If a driver under the age of 18 wants to use a phone while driving, they first must pull over and stop.

Drivers 18 years of age and older are permitted to use cell phones while driving, but only to talk to other people. Drivers over the age of 18 cannot use any type of cellular device to send/receive emails, texting, and/or tweeting. A person caught violating the

new law will be issued a citation and fined \$50.00 for a first offense, and \$100.00 for each subsequent offense. There are no points associated with the offense.

The new law does not apply if a driver uses their phone to contact a public safety entity. Therefore, if a driver calls the police department to report a suspected drunk driver, the new law would not apply to them. In addition, because the new law is a state law, it does not apply to Native Americans who drive on the Reservation.

Colorado is following a growing number of states limiting and/or banning the use of cell phones by drivers. This makes good sense because, while cell phones have their place in modern society, that place is not in the hands persons driving motor vehicles.

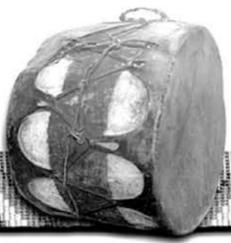



Home Heating and Winter Safety

The high cost of home heating fuels and utilities have caused many Americans to search for alternate sources of home heating. The use of wood burning stoves is growing and space heaters are selling rapidly, or coming out of storage. Fireplaces are burning wood and man made logs. All these methods of heating may be acceptable. They are however, a major contributing factor in residential fires.

Many of these fires can be prevented. You can prevent the loss of life and property resulting from heating fires by being able to identify potential hazards and following these safety tips.

Wood Stoves

Wood stoves cause over 4,000 residential fires every year. Carefully follow the manufacturer's installation and maintenance instructions. Look for solid construction, such as plate steel or cast iron metal. Check for cracks and inspect legs, hinges and door seals for smooth joints and seams. Use only seasoned wood for fuel, not green wood, artificial logs, or trash. Inspect and clean your

pipes and chimneys annually and check monthly for damage or obstructions. Be sure to keep combustible objects at least three feet away from your wood stove.

Electric Space Heaters

Buy only heaters with the Underwriter's Laboratory (UL) safety listing. Check to make sure it has a thermostat control mechanism, and will switch off automatically if the heater falls over. Heaters are not dryers or tables, don't dry clothes or store objects on top of your heater. Space heaters need space, keep combustibles at least three feet away from each heater. Always unplug your electric space heater when not in use.

Kerosene Heaters

Buy only UL-approved heaters and check with your local fire department on the legality of kerosene heater use in your community. Never fill your heater with gasoline or camp stove fuel, both flare-up easily. Only use crystal clear K-1 kerosene. Never overfill any portable heater. Use the kerosene heater in a well ventilated room.

Fireplaces

Fireplaces regularly build up creosote in their chimneys. They need to be cleaned out frequently and chimneys should be inspected for obstructions and cracks to prevent deadly chimney and roof fires. Check to make sure the damper is open before starting any fire. Never burn trash, paper or green wood in your fireplace. These materials cause heavy creosote buildup and are difficult to control. Use a screen heavy enough to stop rolling logs and big enough to cover the entire opening of the fireplace to catch flying sparks. Don't wear loose-fitting clothes near any open flame. Make sure the fire is completely out before leaving the house or going to bed. Store cooled ashes in a tightly sealed metal container outside the home.

Finally, having a working smoke alarm dramatically increases your chances of surviving a fire. And remember to practice a home escape plan frequently.

The Kidney Corner: "CKD and High Blood Pressure"

In the last issue of the Kidney Corner, we discussed diabetes, the most common cause of chronic kidney disease. The next most prevalent cause is hypertension (high blood pressure). Moreover, in almost all causes of chronic kidney disease, hypertension plays a role in its progression. For example if you have chronic kidney disease due to diabetes, control of blood pressure is still very important in slowing the progression of the kidney failure.

Not all patients with hypertension, of course, will develop chronic kidney disease. But the worse the elevation of the blood pressure, the higher the risk of kidney complications. The earliest sign of kidney damage in hypertension is usually loss of albumen, a protein, in the urine, and testing for albumen is a worthwhile test in patients with high blood pressure.

So, to what level should blood pressure be lowered in patients with kidney disease? There is evidence that we should aim for tighter control than we shoot for in patients who do not have disease of their kidneys. Often, blood pressures of 125/80 or

lower are ideal, provided the patient is not having symptoms due to low blood pressure. It is useful to have patients measure blood pressures at home to guide medication use since office-measured blood pressure tends to be artificially elevated due to patient anxiety, the so-called "white coat effect". Home blood pressure monitors are fairly inexpensive. If you have one, keep a record of your blood pressure every time you take it and bring the record with you to your clinic appointments.

Treatment of high blood pressure usually starts with lifestyle changes when appropriate - "Therapeutic Lifestyle Changes". This involves increasing exercise, losing weight when appropriate and decreasing dietary intake of salt.

All blood pressure medications are helpful in delaying progression of kidney disease. However, there are some blood pressure medicines which have extra benefit in this regard. There are two groups of medicines which have been clearly shown to have this property: ACE inhibitors and Angiotensin receptor blockers ("ARB's"). Both are easily available as blood pressure lowering agents and they are first choice blood pressure medications in patients with kidney disease. ACE inhibitors are usually cheaper but can sometimes cause a troublesome cough. Both groups of medicines, ironically, can cause short-term worsening of kidney function despite their significant long-term benefit, so kidney function usually needs to be monitored carefully after starting them. They both can also cause elevation of potassium levels and rarely this can be dangerous to the heart, so this also needs to be monitored in patients taking either of these agents.

So, if you have high blood pressure, don't forget to take your medication regularly! Good blood pressure control will help to protect your kidney function, as well as reducing damage to other organs, such as your heart, brain and eyes.

Road Runner Transit, the transit authority of the Southern Ute Indian Tribe, in partnership with Sky Ute Casino Resort announces that public transit service connecting Ignacio, CO with Aztec NM will begin service at 4:55 AM on Wednesday, December 2, 2009. The service will operate Wednesday through Sunday, and offer seven runs per day. (There will be no service on Mondays or Tuesdays.)

The route will begin at Sky Ute

Casino Resort. The bus stop there is by the statue of the buffalo. The route goes south on Highway 172, with bus stops at the Southern Ute Growth Fund and Ignacio Library. It then travels on La Plata County Roads 318 and 310, then south on US Highway 550, with stops at Bondad and the State Line Thriftway gas station. It continues on Hwy 550 South to Aztec, driving through the Aztec Safeway to the bus stop by the kiosk on N. Main, just south of the Safeway. (Park 'n riders are asked not to park in the Safeway lot.) The bus returns by the same route.

All stops along the way are "sight stops", if no riders request

the stop, or, if no one is standing at the bus stop location, the bus will not stop. Riders at stops between the two end points are asked to be at the stop a few minutes early to be sure of a pickup. Riders may call dispatch at least one hour before a scheduled pickup time at a regular stop to alert drivers of their need for a ride" call (970) 563-4545.

One-way fares are priced by zone at \$1 per zone. Aztec to Ignacio, one way, crosses three zones, the one-way fare is \$3. Riders may purchase a monthly pass for \$60 for unlimited ridership. Punch passes good for 20 zones are available for \$15.







No Shock: All-SPC Packed With 'Cats Attendance Alarming At Girls' Basketball Practices

Leading the conference once more, Ignacio dominated the 2009 All-Southern Peaks football teams when the First, Second, and Honorable Mention rosters were recently released.

With six First Team picks, IHS edged Dolores and Sargent, who each had five honored. And the Bobcats' honored half-dozen were about as clear-cut as choices could be:

QB/S Shane Brooks, OL/DE Chance Wyatt, WR/CB Oakley Hayes, WR/CB Josh Plehinger, LB/RB/K Pedro Vigil, and OL/DE Alex Herrera. Brooks and Wyatt were also voted as the SPC Offensive and Defensive Players of the Year, respectively, but only Vigil will return next season.

"This is a quality group of players that we will definitely miss," head coach Lupe Huerta said in his comments following Ignacio's first-round Class 1A playoff loss to Meeker. "I believe these seniors laid a pretty strong foundation for the returning and future Bobcats."

Wyatt, expected to be a prime contender for a state wrestling finals appearance this season, also scored a second post-football honor. He was nominated by the SoPeaks' coaches to represent the loop in next summer's All-State Game, slated for June 12, 2010 in Greeley—according to the Colorado High School Coaches Association website (chsaa.org has nothing posted as of yet). CHSCA's official selection takes place Sunday.

All three of Ignacio's Second

Team All-SPC recipients can return next season, and all will fill critical roles: junior OL/DL Ryan Brooks, junior LB Ethan Pearson, and sophomore OL/DL Colton Wyatt. And making the most out of his only year in Bobcat black-and-red, senior Tony Hutchinson transferred in and made his mark primarily on defense at safety, with reps as Brooks' backup hard to come by.

The remaining First Team honorees were: Dolores—seniors Pasha Hover and Austin Knuppel, juniors Ryan Greene and Dustin Goodall, sophomore Wyatt Wallace, Sargent—seniors Morgan Biel, Brandon Paulson and Luis Palacios, juniors Marcos Diaz and Erik Schnaderbeck, freshman Colton Cooley, Del Norte—seniors Jake Butler and Chris Archuleta, junior Nick Trujillo, Center—junior Justin Gonzales, sophomore Juan Mariscal.

The following earned Second Team status: CHS—senior David Paez, junior Anthony Garcia, DNHS—senior Kyle Garcia, jun-



After falling in districts, the 'Cats were left on the outside looking in.

But junior Rose Mirabal's development on the outside, hitting in, gave Ignacio a representative on the 2009 All-San Juan Basin League volleyball roster. The announcement came just after the Drum's previous print deadline, and after the SJBL's final hopes—existing only in Class 2A—were eliminated in the Great Eight inside the Denver Coliseum.

Junior Santana Rodriguez, who took over prime libero duties from Katelyn Sivvers for the latter half of the season, was selected Honorable Mention All-SJBL. She joined Norwood sophomore Katelyn Hardman, Ridgway senior Richelle Walker, Telluride sophomore Emy Ludwig, Nucla senior Amanda Church, and Dolores junior Cortney Brunner.

Having recently played for Class 2A's Red team inside Arvada West HS at the Colorado Coaches of Girls' Sports All-State match (Nov. 22), Mancos senior setter Jesse Paquin earned SJBL Player of the Year. Senior teammate Tatum Martinez and DHS senior Tess Wallace also joined Paquin on her side—coached by MHS' Ramona Shepherd—at the CCGS event and were also clear All-SJBL picks.

Lady Jay sophomore outside hitter Aimee Johnson and Lady Bear junior middle Cheyenne McCoy were the other All-League honorees from the

squads. Both teams survived to the final day of the season up in Denver, meaning that IHS will battle two of the classification's reigning top eight—six times in all!—when the 2010 campaign commences.

Dove Creek's season ended in 1A—Region A action at Gunnison HS, just short of also making the Great Eight, but the Lady Bulldogs still had All-SJBL presence in seniors Kayla Pribble (middle, CCGS pick, 1A Blue) and Sonja Strong (OH). Nucla soph OH Taylor Zurich, who also somehow performed cheerleading duties (with assistant v-ball coach Gaye Lynn Zurich overseeing things) for the Lady Mustangs, and THS senior Allisyn Stanfield rounded out the All-League selections.

Ignacio (4-17 overall) and Telluride both had their seasons end in 2A—Dist. 3 play, while both NHS's, Ridgway, and Ouray



The Bobcats' next action before the Christmas break will





Jr. Miss Southern Ute



Mi'que Nu-wa-wok,
Hello Everyone,

My name is A-mya Bison, "White Butterfly Woman", the current Jr. Miss Southern Ute 2009-2010. I am 12 yrs old and attend the Ignacio Jr. High School. My parents are Alberta Bison and the late Arthur Anderson, Jr. My grandparents are Beulah Kent and the late Ronald Bison. My Great-grandparents are Essie Kent and the late Bonny Kent. My family lives here on the Southern Ute Reservation in Ignacio, CO.

I was crowned during our Southern Ute Tribal Fair on September 11, 2009. I was really happy I could hardly speak. I really liked the carnival and the fireworks display. The newly crowned Southern Ute Royalty also helped serve the delicious royalty dinner on Saturday night. Since, I've been crowned Jr. Miss Southern Ute 2009-2010, I have attended several activities and pow wows. I traveled to the Council Tree Pow Wow in Delta, Colorado on September 18-19, 2010. The three sister tribe's royalties were invited to take pictures at the Council Tree with the Elder's and Byron Red. I would also like to thank Byron Red for that lifetime opportunity. Another lifetime moment, I will never forget is traveling to the Smoking River Pow Wow in Meeker, Colorado on September 25-26, 2009. I had the honor of staying in a Historical Hotel, where President Theodore Roosevelt once stayed in The Meeker Hotel.

On October 1, 2009 the Southern Ute Royalty was asked by Larry Tucker to be at the Tamarron Resort along with other dancers to dance for the Growth Fund. Alden Naranjo spoke on behalf of the group and explained the different style of dancing. Next, I traveled to

Colorado Springs, Colorado, on October 10, 2009. I was asked by Mikki Roubideaux to attend the "First Nations Day Celebrations" at the Garden of the Gods. Alexandria Roubideaux, Little Miss Southern Ute, and I made the news that evening. Then on October 20, 2009. The Mayor of Durango read the Proclamation of Indian Heritage Month to both the Southern Ute Tribe and Ute Mountain Ute Tribe. The Royalty had the honors to be with a few of the Southern Ute Tribal Council and Ute Mountain Ute Tribal Council and Royalty. Then the Southern Ute Royalty was asked by the Shining Mountain Committee to help out the tiny tots contest during the 5th Annual "49" Pow Wow on October 24, 2009. Then November 20, 2009 we were asked to be at the Ignacio Public Schools for Native American Heritage Month and I danced along with the other dancers. For our Annual Thanksgiving Dinner at the Sky Ute and Resort, I met an elderly woman from White Mesa. We exchanged information so we may keep in touch with one another. I helped the other royalty girls with the raffle that day. I kept busy and the time went by so fast for me "cause I'm just 5 years old!" In the morning of November 20, 2009 I supported our educational presentation, at Ignacio High School, for the junior high and high school students. Then in the afternoon, we went to the Ignacio Elementary School, the Intermediate students where there, too. I was so glad to see kids my age, usually when I go places I see more adults. And this pass weekend I went to the Fort Duchesne Thanksgiving PowWow. It was a lot of fun for my family and I.

As for December I plan on participating in Ignacio's Taste of Christmas December 4th. December 13th I will be in Bayfield's Christmas parade. December 17th I will be attending the Southern Ute Academy Christmas program. That following weekend I will be helping out with the Southern Ute Christmas Program on December 19th. I plan on spending the Holidays with both my families here in Ignacio and Durango. I am going to continue and represent the Southern Ute Tribe the best that I can.

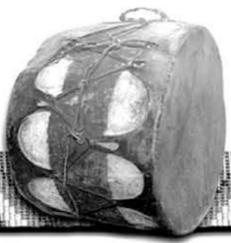

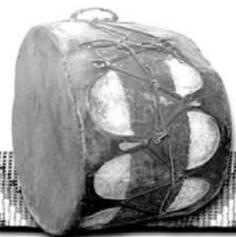



BURN THE RIGHT WOOD, THE RIGHT WAY, IN THE RIGHT WOOD-BURNING APPLIANCE

Did you know that by changing the way you burn wood you can save money, reduce air pollution and protect your health?

Here are a few simple tips to make your fire burn hotter, keep your wallet fatter and keep your local air cleaner and healthier.

-  **Season all firewood.** All firewood should be split, securely covered or stored, and aged for at least six months. Seasoned wood burns hotter, cuts fuel consumption and reduces the amount of smoke your appliance produces.
-  **Choose the right firewood.** Hardwoods are the best. Never burn trash or treated wood which can emit toxic air pollutants.
-  **Start it right.** Use only clean newspaper or dry kindling to start a fire. Never use gasoline, kerosene, charcoal starter, or a propane torch.
-  **Don't let the fire smolder.** Many people think they should let a fire smolder overnight. But reducing the air supply does little for heating and increases air pollution.

-  **Clean ashes from your wood-burning appliance.** Excess ashes can clog the air intake vents reducing efficiency. Be sure to dispose of ashes in a metal container away from the house or any flammable material to reduce the risk of fire.
-  **Keep your chimney clean.** A clean chimney provides good draft for your wood-burning appliance and reduces the risk of a chimney fire. Have a certified professional inspect your chimney once a year.
-  **Be a good neighbor.** Follow best practices for burning wood and always remember to comply with state and local codes.
-  **Follow instructions.** Operate your wood-burning appliance according to the manufacturer's instructions and follow all maintenance procedures.
-  **Upgrade to cleaner equipment.** EPA-certified wood stoves and fireplace inserts burn cleaner and burn wood more efficiently emitting less particle pollution than older models.
-  **Size matters.** Choose the right-sized appliance for your needs. If your wood-burning appliance is too big for your room or house, the fuel will smolder and create more air pollution.
