**TUUCAI WELLNESS COURT JUVENILE  
TERMS & CONDITIONS OF SUPERVISION AGREEMENT**

---

Terms and Conditions of the Juvenile Participant's Supervision are as follows:

1. The Juvenile Participant shall not violate any Tribal, Municipal, State, or Federal Laws while under the supervision of the Wellness Court.
2. The Juvenile Participant shall abide by all orders of the Wellness Court / Southern Ute Tribal Court, whether written or oral.
3. The Juvenile Participant shall appear at all Court proceedings pertaining to this matter as required; (The Juvenile Participant understands that, under Wellness Court Procedure, reviews of this case shall be scheduled on a weekly basis unless otherwise indicated; these Court hearings may ultimately be lessened to bi-monthly and/ or monthly settings, at the discretion of the Wellness Court Judge, dependant upon phase and compliance.)
4. Although Wellness Court is based on a program of incentives and sanctions, whose goal is to prevent re-offending and to assist Juvenile Participant in therapeutic rehabilitation, promoting a healthy lifestyle and community - the Juvenile Participant understands that a set amount of jail-time has been imposed, and stayed, in this case and any non-compliance on the part of Juvenile Participant may result in short terms of this jail-time being imposed immediately. There needs to be something in here regarding the right to have a hearing/due process the determination and discretion of the Wellness Court Judge.
5. The Juvenile Participant understands that this case will be staffed, without the Juvenile Participant's presence, on a weekly basis by a Wellness Court Team which consists of the Wellness Court Judge, any and all Treatment Providers associated with this case, Officers of the Department of Tuucia Wellness Court , and any other party and/ or agency whom the Wellness Court and/ or Juvenile Participant has determined to be necessary to the proceedings of this case, i.e. Division of Social Services, Multi-Systemic Team Members, School/ Educational Representatives, Case Managers, Counselors, Prosecutors, Defense Counsel, etc.
6. The Juvenile Participant shall sign all necessary releases associated with Wellness Court, the Wellness Court Team, and/ or applicable Treatment Providers. Because Juvenile Participant's success in Wellness Court depends on the collaborative effort of all agencies and providers associated with this case, and their ability to discuss related aspects of this case together in a forum in order to formulate the most applicable treatment plan/s, monitor compliance, and assist the Juvenile Participant as a team – the Juvenile Participant understands any failure or refusal to complete the necessary releases is therefore non-compliance to Wellness Court Policy Agreements and will result in an immediate Order to Show Cause issued and an appearance before a Judge, possible Wellness Court Revocation, and the possible imposition of all stayed jail-time.
7. Juvenile Participant shall comply with all requirements of the assessment and evaluation process.
8. The Juvenile Participant shall attend and participate in all classes, counseling sessions, therapy groups, or education as required and recommended by the Wellness Court Treatment Plan.
9. The Juvenile Participant shall not consume or possess alcoholic beverages while under Wellness Court Supervision. The Defendant shall not be in or around establishments that sell or serve alcoholic beverages. The Juvenile Participant shall not consume, inhale, ingest in any manner, or possess illegal drugs and/ or narcotics, except for religious purposes, while under the supervision of the Wellness Court.
10. The Juvenile Participant shall abide by all required Alcohol and/ or Drug testing as imposed by the Wellness Court. The Juvenile Participant further understands that failure to abide by testing requirements and/ or refusal to submit to testing is a serious violation of the Wellness Court Order and this agreement, and will be addressed accordingly.
11. In addition, the Juvenile Participant shall comply with the following terms and conditions:
  - \_\_\_\_The Juvenile Participant shall attend school regularly and maintain passing grades, with no unexcused absences or excessive tardies, and will report any school-related disciplinary actions immediately for review.
  - \_\_\_\_The Juvenile Participant shall abide by a curfew time of \_\_\_\_\_, unless accompanied by a parent, guardian, provider, or other approved adult.
  - \_\_\_\_The Juvenile Participant will obey the orders of his/ her parent or guardian, and abide by the rules of his/ her respective household.

12. Wellness Court Compliance is monitored by the Wellness Court staff:

- The Juvenile Participant shall report to the TüüÇai Wellness Court Department as required.
- The Juvenile Participant shall provide the TüüÇai Wellness Court Department with written proof of attendance, participation in, or completion of, any classes, counseling/ therapy, education, useful public service, apologies, assignments, or other activities as required of the Juvenile Participant as part of Wellness Court Sentencing, the Wellness Court Treatment Plan, and Terms and Conditions of this Supervision upon request.
- The Juvenile Participant shall be required to provide breath and/ or urinalysis samples for testing, at any time, with or without advance notice, at the request of a TüüÇai Wellness Court Officer. Juvenile Participant, unless other arrangements are made, is responsible for all costs and fees associated with such testing.
- The Juvenile Participant, as part of Wellness Court monitoring or sanctioning, may be required to comply with Ankle Bracelet Monitoring and/ or In-Home Sobriety Breath-Alcohol Monitoring, as a component of supervision requirements. Juvenile Participant, unless other arrangements are made, is responsible for all fees associated with such monitoring
- The Juvenile Participant shall permit visits by TüüÇai Wellness Court Staff at home, or elsewhere, at the discretion of the Dept. of TüüÇai Wellness Court Staff and the Juvenile Participant shall admit TüüÇai Wellness Court Staff into his/ her home, or any other building or dwelling occupied by the Juvenile Participant, however briefly, upon request.
- The Juvenile Participant shall keep the Probation and Parole Department informed of his/ her correct mailing and physical address, employment location, and home and employment telephone numbers at all times throughout the term of supervision.
- The Juvenile Participant shall notify the Probation and Parole Department within 72 hours of an arrest or upon the receipt of any citation, petition, or summons and complaint-charging Juvenile Participant with a crime or major traffic offense.

13. It is understood that any serious violation of this order, dependant on circumstances and severity, may result in the immediate arrest of Participant, an Arrest Warrant being filed, or an Order to Show Cause being issued to Participant by an Officer. The Participant will be commanded to appear before a Judge and the Wellness Court as soon as possible to answer to the alleged violation/s.

These Conditions of Supervision have been read by or to Juvenile Participant. The Juvenile Participant, and the Juvenile Participant's parent or guardian, if applicable, represent by signing below that he/ she/ they understand the Wellness Court Concept and it's expectations, these Terms and Conditions of Supervision, and the possible consequences for violation of Wellness Court policy and/ or these terms and conditions.
