The Juvenile was placed under the supervision of the Probation Department for a period of _____ days/months by order of the Southern Ute Indian Tribal Court on _____. The term of supervision commences on _____ and expires on _____ unless shortened or extended by the court. The terms and conditions of the Juvenile's supervision are as follows:

1. The Juvenile shall not violate any tribal, municipal, state or federal laws while under the supervision of the Probation Department.
2. The Juvenile shall abide by all orders of the Southern Ute Tribal Court, whether written or verbal.
3. The Juvenile and his/her guardian/parent shall appear at all Court proceedings pertaining to this matter as required.
4. The Juvenile shall not change his/her residential address without obtaining the permission of a probation officer.
5. The Juvenile may travel within a hundred mile radius of his/her residence. Travel outside this radius is allowable with the prior approval of the Probation Department. The Juvenile must submit written travel request 48 hours prior to your departure.
6. The Juvenile and his/her guardian/parent shall permit visits by probation officer at home, school or elsewhere as desired by the probation officer.
7. The Juvenile and his/her guardian/parent shall report to the Probation Department as required and submit a written supervision report and provide any other requested information.
8. The Juvenile shall obtain any evaluation(s) required by the court and follow the recommendation of said evaluation(s).
9. The Juvenile shall provide breath and/or urine samples for testing at any time upon request by a probation officer, with or without advance notice, and pay any and all fees and costs associated with such tests.
10. The Juvenile shall notify the Probation Department within seventy-two (72) hours of any police contact.

11. The Juvenile shall attend school regularly with no unexcused absences.
12. The Juvenile shall abide by a curfew of ____ o'clock, __.m. The Juvenile shall not be out after that time unless accompanied by a parent, guardian, probation officer, or other authorized adult, or unless participating in an authorized school activity.
13. The Juvenile shall not use any form of alcohol, including products such as cough syrup, mouthwash, etc., that have alcohol in them. The Juvenile shall not remain in the company of persons who are intoxicated.
14. The Juvenile shall not be in a bar or establishment whose primary business is the sale of alcohol.
15. The Juvenile shall not use or possess illegal drugs. The Juvenile must inform the Probation Department of all prescribed medications. The Juvenile shall not remain in the company of persons who possess illegal drugs.

These Conditions of Supervision have been read by or to the Juvenile. The Juvenile, and the Juvenile's parent or guardian, represent by signing below that he/she/they understand the terms and conditions of supervision and the possible consequences of violating them and have received a copy of them.
