The Southern Ute Indian Tribe (SUIT) is announcing the transition of their Tribal Member Health Benefit Plan to the Forest County Potawatomi Insurance Department as their new Third-Party Administrator.

Following is a sample copy of the new member ID card. Please ensure your staff requests a copy of the member's new ID Card during their next visit. New ID numbers have been assigned to all members. Please use this letter as your official notice of this change.

You may use the information on this letter to access the SUIT Tribal Member Health Benefit Plan contacts. The SUIT employee health plan is **not** combined with or a part of the SUIT Tribal Member Health Benefit Plan. Any other coverages for these members would be considered primary.

Permanent ID Cards for each member will be effective **September 1, 2019**.
