INFORMATION FOR DEFENDANT'S COUNTERCLAIM

- A. When you have been served with a summons to appear for trial in a civil action filed against you in Tribal Court you may if you do not wish to contest Plaintiff's claims.
 - 1. Make an out of court settlement with the plaintiff before the date set for trial and notify the court clerk, in writing, of the settlement.
 - Not appear at the date and time set for trial, in which case the court will enter default judgment against you for the amount claimed owed by Plaintiff plus costs.
- B. If you wish to contest the claim filed against you must complete and file the response form, AND APPEAR ON THE DATE AND TIME SET FORTH in the notice. Bring all books, papers and witnesses needed to establish your defense. Subpoenas should be made 5 days prior to hearing.
- C. If you have a claim against the Plaintiff, or a setoff to the Plaintiff's claim, you may assert a counterclaim or setoff against the Plaintiff by completing the Defendant's Counterclaim and paying a \$50.00 filing fee.
- D. If Plaintiff recovers a judgment against you, the Plaintiff is entitled to immediate payment of the full Amount of the judgement plus court costs. Payment must be made to the clerk of the court. You are entitled to receive a satisfaction of judgment form upon payment. If you do not immediately pay the judgment amount you must complete and return the Interrogatories Form" listing your property and other assets.
- E. If you contest the claim, you have a right to a right to a Trial to the Court. If you wish to appeal any decision of this court, you must follow the appellate procedures set forth in the Tribal Code.
