New Business

Review and Approve April 24, 2018 Agenda

Minor Source Program

Refresher on the Three Options for Minor Source Program

Mr. Oakley Hayes, AQ Technical Manager, presented the review and recommendation of the potential Minor Source Program (MSP). The information included a timeline, three options to regulate minor sources and the Tribe's recommendation to the Southern Ute Indian Tribe/State of Colorado Environmental Commission (Commission) for approval.

The Tribe's recommendation to the Commission is option two – the Commission authorizes the Tribe to apply for administrative delegation of the federal minor source program.

Letters Received from La Plata County, State of Colorado and Archuleta County

It was the consensus of the Commissioners to hear a summary of the letters received from La Plata County, Archuleta County and State of Colorado. Mr. Danny Powers, AQ Program Manager, provided a summary of the letters in support of the tribal MSP.

Background information:

On December 3, 2018 the Commissioners received a letter via email from La Plata County requesting to delay the approval of the proposed Minor Source Program (MSP). The letter was not included in the official commission meeting packet emailed to the Commissioners on November 19, 2018. At the December 5, 2018 meeting, the Commission agreed unanimously to table the vote on an option for approval of the MSP and requested the Air Quality Program schedule a meeting with La Plata County, Archuleta County and Tribal Council as part of the stakeholder process.

Public Comment
