## PART I – PURPOSE, AUTHORITY, APPLICATION

#### A. Purpose

In 2023, the Southern Ute Indian Tribe revised the Criminal Code and developed a Criminal Penalty Schedule pursuant to §5-15-101(1) that provides various classes of offenses with associated penalties. The Criminal Penalty Schedule appears in Part II of these guidelines.

## **B.** Authority

The Tribe enacted the Criminal Code pursuant to its Constitution, Article VII, Section 1(e). The Constitution authorizes the Tribal Council to govern the administration of justice through the tribal courts and to prescribe the powers, rules, and procedures of the tribal courts in the adjudication of cases involving criminal offenses and civil actions. The Criminal Code, at §5-15-101(1), provides that criminal offenses will be sentenced in accordance with the Criminal Penalty Schedule.

## C. Application

The Criminal Penalty Schedule applies to penalties assessed pursuant to the Criminal Code.

## PART III – ADDITIONAL OFFENSES

#### A. Criminal Attempt

Offenses charged as criminal attempt offenses should be charged under the same penalty class as the related offense.

#### B. Offenses without specified penalties

For any criminal offense not listed in the Criminal Penalty Schedule or containing a specified penalty in the Criminal Code, the Court may impose a sentence or penalty in accordance with offenses of similar magnitude in the Code and Schedule.

## C. Sentence Enhancement

Offenses for which there is sentence enhancement are listed in the Criminal Penalty Schedule.
